Our agreement

This is a summary of some the conditions of purchase which form part of the Contract for pieNETWORKS to supply you with a pieLINK Internet Equipment. "pieNETWORKS" means pieNETWORKS Limited ACN 078 661 444, ABN 27 078 661 444 its successors and/or assigns;

Hardware (pieLINK) – You own the hardware and you are entitled to the ‘pay to use revenue’ it generates.

Software – You use our software under the terms of the license agreement. You cannot sell or copy the software. A fee applies for the use of our software, currently \$2.20 per day. We will invoice you in advance quarterly or annually – whichever you prefer. A discount is provided if you pay annually.

Advertising - pieNETWORKS can display any advertising images on the scrolling screens or pieWIFI web pages at its discretion.

Risk - You will assume all risk of physical loss or damage to the pieLINKI including during transit. Transit insurance is available on request.

Title – The pieLINK is not yours until you have paid for it.

Notices – Correspondence and invoices will be sent to you in writing, by facsimile or by e-mail at the last address or number advised by you.

Warranty (Return to Base) – Applies to the original purchaser for a period of 12 months on the central processing unit (“CPU”); the chassis, power adaptor, wireless access point and signal booster. If it doesn’t work and it’s our fault we will fix it. If it doesn’t work and it’s not our fault, we will fix it and send you the bill.

Termination – If you fail to comply with any terms of this Licence Agreement, your licence agreement may be terminated by pieNETWORKS with 7 days notice. Failure to comply includes non-payment of the Licence Fee by the Purchaser to pieNETWORKS. In which case the pieLINK software will not work.

Resale - The Licence Agreement is NOT TRANSFERRABLE. In the event of change of ownership of the pieLINK you should notify pieNETWORKS of the sale of the pieLINK and the name and contact details of the new owner. You must also tell the new owner that they will need to enter into a license agreement with pieNETWORKS so we can change the pieLINK’s settings to new owner’s details. An administration fee is payable by the new owner of the pieLINK to pieNETWORKS.

Acceptance - When you sign this agreement you confirm that you will **read** and **notify** pieNETWORKS of your acceptance of all of the terms and conditions of the Contract by visiting their web site at:

Payment – No work will commence until you have paid for your pieLINK. All figures quoted include GST. A tax invoice will be supplied by pieNETWORKS for the hardware selected overleaf.
